## **Delegate's Report**– Joe B. Hello everyone;

- I submitted our Area's Archives Committee Proposal to New York, I was contacted later by the Conference Coordinator, he told me that this is already on the Agenda for the conference but our Proposal will be added to the background material.

- I was pleasantly surprised to receive my correspondence from the grapevine this last week. In it I received a summery of this month's La Vina. One of the title stories is "We are not a Group of Bad Tempered People." The story, from Puerto Rico, tells of how members play guitar and fellowship before and after the meetings. There was also a story about how they are using Public Information to carry the message in Peru using a radio show called "Anonymous Alcoholics Hour". I have a copy of La Vina and that Grapevine for anyone who has never seen one or read one or just plain wants one.
- I have been asked to collect stories on remote communities to submit to the Remote Communities Newsletter. The definition of remote community is generally understood to be "any community where it is difficult to carry the message because of language, culture or geography".

This as far as I know will be big and we will have a very short time to the changes. The deadline for the change is April 15<sup>th</sup>. As soon as I get them I will try to find you and deliver these to you and make sure you look at them. I also visited some Districts but for some reason I didn't note the districts; next month I will make sure to write down to add to my report. I was at the registration table and we have 146 in attendance today. Thank you so much.

Area Chair: Jason S. During the first 41 days of Panel 58 we've had many events already. We had the January Assembly and I really want to congratulate you on all the work that was done at the Assembly. In addition to electing and confirming all the Standing Committees Chairs, you were also able to complete 12 items of business. The Standing Committee Chair orientation was a great success and the DCMC orientation will be March 29<sup>th</sup> at the archives in Riverside; if you are a new DCMC or DCM please do not leave today without a flyer. There is another flyer on the website for the DCMC Orientation on March 29<sup>th</sup>. It will be an opportunity to meet with other DCMCs and DCMs and area officers to discuss just how it is that we can better help and assist the Districts and just what it is that the Districts can do to assist the Area. One of the things we'd like to see happen in the next few years is that we would like to see an increase in GSRs and many Districts are gearing up with that goal in

mind also. In these 41 days I have also been able to visit District 18, where I saw lots of excitement and enthusiasm from their GSRs and District 6 as well is very active and enthusiastic: they are increasing in size and had 41 in attendance. All in all, I think the Districts are doing very well. I also want to thank everyone for the work at the Assembly. As we went through the work rather quickly, I wanted to give some feed back that I got from the Area Assembly. There are many things that are difficult when you're new and one of the things I'd like to talk about today is that we have a few changes in the order of procedure for the agenda. We have given another half hour to the Delegate Sharing Session and we have moved the Committee Meetings to after lunch. Now the order after the Delegate Sharing Session is: Area Business, Committee and District reports, lunch and then the Committee Meetings. Please give us any feed back you may have on how this works out for you please let us know. Of the things we have done as Area Officers, one of the things that didn't go quite as smoothly as we might have liked is regarding the purchase of the sound equipment. So I have a statement I'd like to read at this point.

After reviewing the Guidelines, Area Purchasing Policies & Procedures, Tradition 2 and Concept X, and speaking with many members of the Assembly, I would like to communicate the following:

In light of the recently completed purchase of replacement equipment for the Area Sound System, and in reviewing past purchases made during the terms of the three most recently serving Panels, I have come to realize that your Area Officers relied greatly on the assumption of precedent based on actions which, as it turns out, may have been outside of the Area Guidelines. I have been reminded that as your Area Chair, my duties include ensuring the health of the Area. Therefore, as your trusted servant, I offer my humble apology for action taken by me individually or as an Area Officer which was not within the current Guidelines, and despite conflicts between Guidelines and Policies and Procedures as they presently stand, I believe my responsibility is first and foremost to ensure that the Guidelines are always followed. Therefore, whatever the history of purchasing procedures by currently serving or past Area Officers, we ought not and will not repeat the same actions, which place us in conflict with the Guidelines and with other members.

At the January Assembly, I appointed an Ad Hoc committee to review our Guidelines and to make recommendations they deem desirable. I will now ask them specifically to review the purchasing policies and procedures as they now stand. There is inherent conflict between Committee guidelines, Area Guidelines and customary purchasing procedures, which we can now see clearly. Having now opened a forum for discussion on these policies and Guidelines, I look forward to moving on and learning from our experience.

Throughout all the rancor and discussion of the last month, one thing has become very clear to me. Each of us serves because of a great passion for Alcoholics Anonymous, and despite our various interpretations of procedures, we are spiritually united in wanting the best for our Area. But as Bill W. wrote, the good is often the enemy of the best. And since my best is the least I can do for Alcoholics Anonymous, I assure you that in the future, and to the best of my ability, due diligence will be taken to ensure that no action will be taken which is outside the Guidelines of the Area or that could be divisive in nature.
