Meeting was called to order by Chair Ramon at 12:00 p.m.

Introductions: Past Trustees, Past Delegates, New DCMCs/Alt. DCMCs, New DCMs/Alt. DCMs, New GSRs/Alt. GSRs, Guests, Past, and Current Area Officers. (Pete B, Past Delegate for Panel 52 and current Archivist is attending his last ASC today; having served MSCA 09 for 28 years, he is moving out of state).

Here are some of the things that have occurred since or last meeting: 1) The Records Department has implemented a ticketing system as of June 28th. This is an automated system that gives a response number to help keep track of inquiries. 2) Attended the Foro de MSCA in Buena Park on July 10th. 3) Attended the Orange County Intergroup Association of Alcoholics Anonymous Meeting July 13th in Costa Mesa. 4) Attended the District 05 Delegate's General Service Conference Report on August 11th. 5) Currently working with Tanya D, the Area 09 CPC English Co-Chair, to ensure District Chairs get their CPC kits. 6) There have been 56 group / officer changes entered into the FNV database since our last Area Service Committee Meeting hosted by District 08. 7) Created a modified version of the form F-43 (DCM/DCMC change form) to also include other District officers. I worked with Julius Y to get a formal request from HASBYAA to host the ACYPAA 2018 convention, which is on today's agenda with copies on the back table. Thanks to Diane for correcting and completing the 2017 Calendar of events, which I eblasted several weeks ago, and is available on the back table. It was my pleasure to attend the 20th Anniversary celebration of La Viña July 23 and 24 in Phoenix, AZ.

Area Chair Ramon D: I am slowly getting back on track after five weeks vacation in Honduras. My work in AA is to pass it on, not to keep it to myself. Thanks for letting me be of service.

Old Business:

- HASBYPAA request to host 2018 ACYPAA Convention Julius Y is a member of HASBYPAA who represents that group. His group formally asked MSCA 09 to endorse their bid to host the 2018 ACYPAA convention, which has not been in their area since 1970. There was a majority vote (one opposed who did not state their minority opinion) to put this on the agenda for the September ASA for a formal vote.
- Guidelines and Policy (GAP) Committee Guidelines Judy B indicated that the new, proposed Guidelines for the GAP Committee were provided in English and Spanish for review. Don offered a friendly amendment to have the Literature Guidelines Article 7, Section G eliminated to be complimentary with the proposed GAP Guidelines. Have the draft GAP Guidelines been formally submitted to the Literature Committee? Judy B indicated that the draft Guidelines have not been formally submitted to the Literature Committee. The Literature Committee's function is to ensure that any proposed Guidelines do not conflict with Bylaws and Guidelines. Judy B made a motion from the floor, which was approved by a majority vote, to table this issue until more discussion can occur, including review by Literature Committee.
- 2017 Calendar of Events The schedule needs to be changed from December 12th to December 10th, as the 12th is on a Tuesday. We need to change the calendar to show that District 23 will host the May ASA on 21 May 2017, and District 25 and 8 (to be confirmed) would host the July 9 FORO. Following a motion and second, the vote was unanimous to take the revised calendar to the September ASA.
