## Pacific Regional Forum

June 23-25, 2006

There will be a Pacific Regional Forum June 23-25, 2006 in Seattle, Washington, and all AAs are welcome to attend.

Regional Forums are weekend sharing sessions, designed to improve communications among AA members, the General Service Board, and the GSO/Grapevine staffs.

Forums provide unique opportunities to share experience, strength and hope, to ask questions and spark new ideas. Many cite their experience at a Regional Forum as the reason for their involvement in general service work.

The Forum will be held at the Doubletree Airport Hotel, 18740 Pacific Highway South, Seattle, WA 98188. If you wish to reserve a room at this hotel, you can call them at 206-246-8600, and advise the reservation desk (by June 2) that you are attending the Pacific Regional Forum for a special room rate of \$89.00 (plus tax).

This forum will be hosted by Area 72 (Western Washington), and coordinated by the US/Canada General Service board. You can visit [www.aa.org](http://www.aa.org) for more information. There is no fee for registration, and you can register over the internet at the AA.org website. (Just go to [www.aa.org](http://www.aa.org), then click on "Services for Members", then click on "Regional and Special Forums", then scroll to the bottom of that page and click on "Online Forum Registration". Then fill out the information requested. Online registrations must be received before **Monday, June 19, 2006** in order to be processed. If you miss the deadline the General Service Office welcomes on-site registration. It is not necessary to call G.S.O. to pre-register; advance registration simply helps their planning.






