topic will be visible to all on our MSCA website. All MSCA trusted servants and Standing Committees are encouraged to suggest topics for these discussions. Topics will then be selected and approved by the EMSC. In the time frame leading up to the annual General Service Conference, the EMSC will customarily post topics regarding items on the General Service Conference agenda. The forum will be governed by the content guidelines outlined in the MSCA Newsletter Committee Guidelines (e.g. will conform to traditions and concepts, will not break anonymity, etc.). All forum entries will be reviewed by the EMSC for content prior to posting to the forum. Additionally, the following points of decorum will be observed:

- No names will be posted
- No entries which attack or criticize another person will be posted.
- No entries mentioning outside issues in a controversial or provocative manner will be posted
- No entries containing profanity will be posted
- Entries found objectionable by 2/3 of the EMSC will not be posted.

The time frame for which any topic is open for posting will be determined by vote of the EMSC. All discussion topics and the postings will be archived and available for viewing on the EMSC webpage for a period not less than one year.

CONCEPT VI

The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

Now, wait a minute, you say! All along you have been telling us that the Groups are the boss. This concept says, flat out, that the General Service Board has "chief initiative and active responsibility in most world service matters". That sounds an awful lot like a definition of "boss".

The 12 Concepts For World Service, when taken as a whole, define legal authority as opposed to practical authority. Because the General Service Board, through its charter, is a legal entity, it must be governed by legal language. This language gives the General Service Board the chief initiative and active responsibility listed in this Concept.

Bill W. basically set up the A.A. Service Structure along the lines of a corporation. In Bill's essays on the 12 Concepts, found in the A.A. Service Manual, he outlines his reasons for choosing that structure, as opposed to an institutional or government-like structure (the what!? That's right, we actually have An A.A. Service Manual – check it out at the Central Office, or online at aa.org under SERVICES FOR MEMBERS). However, and this is vital to the working relationship between the General Service Conference and the General Service Board, the Board has always realized

that the practical authority held by the Conference grants the power of a *final decision* to the Conference. The Board has NEVER vetoed or over-ruled the Conference. And we'll see why in the following report on Concept VII.

Concept VII – Legal vs Traditional Authority

Concept VII (short form) The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.

This concept spells out the exact relationship of the General Service Board to the General Service Conference, and therefore to the A.A. Groups. It says that the General Service Board, out of necessity, is given legal authority, through the Charter and Bylaws of the General Service Board, (whoa, doesn't that sound like legal terminology!) to manage the affairs of the General Service Office and the two legal corporations – Alcoholics Anonymous World Service (AAWS) and the A.A. Grapevine. I can hear you now, "Hey, you told us earlier that the Groups are in charge. This sounds like some board of trustees is making all the decisions". Please read past the semi-colon.

The concept goes on to say that the General Service Conference, representing the Groups, relies upon tradition and the A.A. purse for final effectiveness. In the long form, it is much more descriptive – it says that the General Service Conference ".... relies instead upon the *force* of tradition and the *power* of the A.A. purse for its final effectiveness" (Italics, bolding and underlining added by author). Looking especially at Traditions 2 and 9, we see that the *ultimate* authority comes from the Group conscience, and that the Service Boards and Committees are directly responsible to those they serve. This is the force of tradition spelled out in this concept.

But what about the *power of the purse*, what is that? In the power of the purse lies the ultimate power, one that has never had to be used on a massive scale. This is where the Groups simply withhold their voluntary contributions to the General Service Office, (G.S.O.) because they believe that the General Service Board, or the General Service Conference has grossly erred in their decision(s). Without voluntary group contributions, G.S.O. would cease to operate. Strong medicine, indeed!

It should be evident that the *power of the purse* works at all levels of service, G.S.O., the District Committee, the Area Assembly, Central Office and the Hospitals & Institutions Committee. All service boards and committees must remember that the A.A. Groups hold the purse strings. The consequences of ignoring this power invested in the A.A. Groups are dire.

today is shaped by what Alcoholics Anonymous did and does for me. When I came to AA you couldn't call me a bigot because I hated everyone and everything, you gave me love and tolerance. Strangers told me to "keep coming back" when I didn't even want to be there. Your actions taught me to believe in the principles of AA and trust my higher power as expressed in our group conscience. I think it no mistake our first tradition states: "Each member of Alcoholics Anonymous is but a small part of the great whole. AA must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare comes close afterward." I hope that all of us can agree that AA's common welfare must come first and unity of action should be our goal.

We all have needs, desires, opinions, thoughts that if left unchecked could endanger ourselves and others. I have lots of people that I run things by because I know my thoughts are suspect. This article I showed to a few people in order make sure it expresses my inspiration and my experience rather then my opinion. If we all can agree that our common purpose is to stay sober and carry the message, why can't we agree to do that in a united way as expressed in our Big Book, our twelve traditions and our twelve concepts? Before you rise up from your chair to object, let's do a little personal inventory shall we? I don't always think the group conscience is right but it is the group conscience. Do I put my feelings, my personal desires or opinions before the welfare of the group? Yes it is that simple and that clear-cut. Do I follow personalities rather then the principles of this program? You have taught me that no one is above our steps or traditions and that just because you gave me the "Right of Decision" it can never override those steps and traditions. Just like our three legacy's, the steps, traditions and concepts need each other to function.

Unity is a strange thing, we individuals come together from all types of backgrounds and social strata, yet we unite against our common foe alcoholism. We have many different experiences, sometimes different languages and cultures. Alcoholics Anonymous did for us what we as individuals could not even dream of doing, carry our message across this planet. Remember we did this together, not just as one man or woman at a microphone, but millions of alcoholics standing side by side hands out-stretched. Over twenty years many hands have reached out to me and I owe a debt which I can never fully repay. This year's General Service Conference theme is "Sponsorship, Service and Self-Support in a Changing World". Boy, what an appropriate theme I thought as looked around at all of the differing opinions as to what we should be or not be doing in AA. Some would rewrite the Big Book to better

reflect the times we are living in, some want to go back to the first printing of the manuscript. I hear a lot about trusting our trusted servants and yet don't we trust those that went before us enough to do what they did? Those blasted traditions protect AA from people just like me. I'm selfish and self-centered and think it would be a lot easier if you just did it my way! Thank God for those traditions like anonymity that keeps my head from getting so big that it explodes!

It is my honor and privilege to serve MSCA as your treasurer but I've learned thru hard experience that before I try to reinvent the wheel, I better check to see if someone already had a better idea. My father-in-law always likes to say that to change is not always to improve but without change there can be no improvement. Change for the sake of change isn't improvement. Alcoholics Anonymous works slowly to make sure every voice is heard, minority opinions voiced, best ideas put forward and what is best for the whole comes first. We don't always agree on what is best for AA and our groups but we should at least agree to disagree in a civil manner. If we can't do that who do we serve but ourselves? I am willing to go anywhere, to any length to carry the message but I won't violate the steps, traditions or concepts to do so. I love AA and hope in the future many united hands are there as they were for me. It should always be about principles and not personalities. Our three legacies ensure that we along with those yet unborn will enjoy the fruits of the tree planted by Bill and Bob.

Regional Forums originated in 1975 at the suggestion of the late Chair Emeritus of the General Service Board of Trustees, Dr. Jack Norris (nonalcoholic). They are weekend sharing and informational sessions designed to help the General Service Board, A.A. World Services, Inc., the Grapevine Corporate Board, the Grapevine Staff, and the General Service Office Staff stay in touch with trusted servants throughout the A.A. service structure.

Forums are intended to be sharing sessions, thus no formal actions result. Forums provide unique opportunities to share and exchange valuable experience, ask questions and spark new ideas. Concept VI (long form)

On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief active initiative and the responsibility in most of these matters should be exercised primarily bγ the Trustee members of the Conference when thev act amona themselves the General as Service Board of Alcoholics Anonymous.

Tradition 6 (long form)


Our A.A. experience has taught us that:

Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the Hence such facilities groups. ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

Foro de MSCA "Changing Lives through Service"


(Hosted by Districts 5 & 20), July 9, 2006, Masonic Lodge, 11270 Acacia Parkway, Garden Grove, CA 92840
