GSR Preamble History

The GSR Preamble

We are the General Service Representatives. We are the link in the chain of communication for our groups with the General Service Conference and the world of A.A.

We realize the ultimate authority is a loving God as he may express Himself in our Group Conscience. As trusted servants, our job is to bring information to our groups in order that they can reach an informed group conscience. In passing along this group conscience, we are helping to maintain the unity and strength so vital to our fellowship.

Let us, therefore, have the patience and tolerance to listen while others share, the courage to speak up when we have something to share, and the wisdom to do what is right for our group and A.A. as a whole.

History:

The GSR Preamble as stated above, got it's start right here in Southern California and Area 9 in particular. During the time that Genevieve L. was the Panel 24 (1974-75) Delegate of Mid-Southern California Area 9, someone came up with a Preamble to read at Area meetings which was quite a strong directive to GSRs making them the ultimate authority over Alcoholics Anonymous. Gene asked Goldene L., who was the Area Treasurer at the time, to come up with something to soften this Preamble. She did and she came up with the one they are still using today. Goldene L. would later go on and serve as Area 9 Panel 28 (1978-79) Delegate.

The Central Intergroup Office of the Desert, Palm Springs, California printed the G.S.R. Preamble in its May 1988 issue of their newsletter. The GSO staff picks up on it and ran short article and reprints the preamble in the August/September 1989 issue of Box 459. This preamble is being used in many of the Areas throughout the United States and Canada today.

I will have lots of information for everyone at the February ASC, including a short report of my experience at the General Service Board weekend in New York.



The COMMUNICATION EQUIPMENT SUB-COMMITTEE (CESC) NEEDS YOU for the rest of 2009!

What does the CESC do? As part of the Area Communications Committee (ACC), the CESC, <u>always in cooperation with the Finance Committee</u>, is charged with the following:

Maintaining an inventory of the following equipment owned by MSCA:

audio/visual equipment, translation equipment, software,

computers and printers, and
When requested by the ACC, the CESC is

responsible for researching, evaluating and preparing a written recommendation (including cost estimates) for any electronic equipment, computer software or repairs to electronic equipment. In most instances, it is strongly suggested that at least three sources, along with the corresponding cost estimates, be provided as part of the evaluation.

Will take responsibility for the lawful disposal of any broken equipment or obsolete software having to do with communication equipment as described above.

On an annual basis, in the third quarter, prepare a report of all electronic equipment that would be a candidate for replacement, with costs and prioritization for the purchases. This report would be presented to the ACC Chair no later than September 30th of each year. The preparation of this report is a yearlong activity. The CESC should work closely with all MSCA standing committees and subcommittees, the Area Officers committee and especially with the Area Finance Committee for the purpose of ensuring that a comprehensive, accurate and prudent report is prepared.

OFFICERS: The sub-committee shall have a Chair and Alternate Chair. The term of office is two (2) years beginning January 1 of even numbered years. The officers shall be elected biannually prior to even-numbered years within the Area Communications Committee by a simple majority vote.

MEMBERSHIP: This sub-committee should have a workable contingent of members. The Area Audio Equipment Operator (Sound Dude) is a voting member of this sub-committee. It is desirable that this sub-committee recruits and retains a list of names and contact information of A.A. members competent in the research and evaluation of electronic equipment of all kinds necessary to meet the electronic equipment needs of MSCA.

MEETINGS: The CESC will meet at each Area Service Committee meeting and Area Assembly and other times as necessary.

FUNDING: The CESC will prepare and submit a budget for this sub-committee to the Area Communications Committee Chairperson no later than August of each year.

FULL DISCLOSURE: This position does not carry a voting right at the Area Assembly. You're in it for the spiritual rewards!



PRAASA coming Mar. 6-8

The 42nd PRAASA Assembly will be held at the Marriott City Center Hotel and Convention Center at 1001 Broadway, Oakland CA, 94607. The program will start at approximately 1pm on Friday March 6th and end at noon on the 8th.

The convention hotel is close to the 880 Freeway and Oakland International Airport. Travel from the airport to the hotel will be by shuttle and Bay Area Rapid Transit (BART) train. BART trains are also available from the San Francisco International Airport and a BART station is just two blocks from the hotel.

What is PRAASA?

PRAASA is the Pacific Region Alcoholics Anonymous Service Assembly. It is a yearly assembly held in different parts of the Pacific Region of Alcoholics Anonymous.

The purpose of PRAASA is to develop greater unity among the members, groups, and Areas of the Pacific Region; to encourage the exchange of ideas and experiences; and to provide an opportunity for members to discuss pertinent aspects of AA. The Assembly and the PRAASA committee should always foster the Recovery, Unity and Service legacies of AA.

PRAASA 09 Hotel Accomodations

All rooms at the Marriott City Center hotel have been reserved.

In Memory of Mary Ann M.

In December 2008, AA lost one of its most trusted servants. She died sober with over 30 years of sobriety, but the length of her sobriety was not why most of us will remember her. We will remember her because of her service.

I first met Mary Ann M. around the end of the year in 1981. At the time I was coming up on two years of sobriety. I had picked up the brochure that stated that the General Service Representative (GSR) may be the most important job in AA, and was interested. I didn't understand much of the information in the brochure, but I was intrigued and found out that my home group did not have a GSR. I ran unopposed (volunteered) for the position, and found out that the monthly District 6 meeting was in a parochial school classroom in Huntington Beach.

There were about 5 other GSR's present that night plus Mary Ann, who was the District Committee Member (DCM). They were studying the AA Service Manual, and the Twelve Concepts for World Service. I don't remember much about the Service Manual, or the Twelve Concepts, but I do remember that Mary Ann was kind, welcoming, enthusiastic about General Service, and a great example of the way we work together for the good of AA. I have been connected with General Service in one way or another ever since, and have always valued her example.

In the months and years following that first district meeting, I met Mary Ann in many different service functions. I met her at Intergroup gatherings, H & I orientations, Conventions, and of course regular AA meetings. The one thing I noticed was that where there was a need, she was always willing to give of her time and experience.

She slipped away from us quietly, but she left an enormous hole in our hearts, and will be missed by all those she touched. She leaves several opportunities to participate in service vacant and ready for others to step up as she always did.
