

I love God, AA, Area09 and the opportunity I have been given as a result of stating, "Available," when asked by Rod at our election assembly back in 2011.

Here are some of the things I have learned, and suggest for our continued effectiveness in the future:

- 1. We need to put forth the effort to apply for a new Delegate Area. In other words, **WE NEED TO SPLIT THE AREA!** We have the resources to support two Areas easily, and should remove the fear and doubt and put forth the effort to figure out how to make this work. (I will talk about this in the coming months.)
- 2. Our budget is grossly misdirected. Maybe grossly isn't the best word, but it needs overhauling.
- 3. Our efforts are grossly misdirected. Only a few voices get heard. Seldom, if ever, do we hear the needs of the Groups or Districts, while spending time trying to create credit for an entity that doesn't need credit. (Oh yeah, we already established it when we leased the printer)
- 4. We need to support and encourage the efforts of Committees. There is not enough encouragement nor finances available. We should fund the committees first, so they do not feel limited in their abilities to put on workshops, or get out to the Districts to do their work.
- 5. We need to develop Digital Archives, to reduce the 23% of our overall budget or the 74% of the Committee's budgets that the Archives devours. Everything cannot be online, but there is a lot of material that could be utilized by our membership that can and should be made available at our disposal. The storage space we use now is not climate controlled nor available to the members. Digitally, I could have access to valuable information that I can share with members who need it.
- 6. We need to develop the use of technologically advanced software in our Area. This can save us money with online business meetings, save money in mileage, copies, and put more info at our fingertips.
- 7. We need to have OPEN MIC participation during our ASC's and Assemblies to hear the voice of the Area. PRAASA is such a great vehicle for voices to be heard. We have all learned so much from the microphone time, and it should be utilized in our Area more.
- 8. The Finance Committee has been the tail that wags the dog. No one can be on the committee unless invited? Come On...nothing more to be said.
- 9. We should be careful as we move into the future because AA is not above the law. When we sign corporate papers, there is a commitment to act according to the law. In a 501(c)(3) corporation, there is much to lose when there is marginal abiding of the law. Be Careful!
- 10. Always be honest, fair, informative, loving, kind, honest, and fair.

I know people may not like that which is being presented here, but this is my "Swan Song" as the Delegate. The next time most of you see me, I won't be the Delegate, and you can honestly tell me that which you may want to say. But, until 11:59pm, December 31st, I will still have the honor, privilege, responsibility and desire to serve you as the Panel 62 Area 09 Delegate. Thank you for allowing me to serve you.

# **LONG-TIME A.A. RECALLS SERVICE HISTORY**

I arrived in AA completely defeated for the second time after five years, with no other choice because I tried different ways to drink alcohol moderately and all failed. In fact, I set a goal for myself; to try the program for about three years because I believed I was smart enough to set my own terms.

I started to attend meetings and I became interested and I liked the fact that those people remained sober day in and day out. In those days, almost no literature was available and what we did have was limited to pamphlets and old books. We knew nothing of the traditions and never heard of the 12 concepts. It was a non-written program and we had to follow whatever the old timers suggested but it was up to the new comer to find the information and learn as much as possible. I stayed around for a few years and became a little bored with the whole thing 'the same ol' same ol' and was not attending meeting as often. Finally, at the end of one year they had a special business meeting to elect new trusted servants for the meeting.

They always held the business meeting after the regular meeting but I had never stayed for that. I didn't know what it was for and didn't care either but that day my sponsor was there and he told me I should stay because he knew I didn't like the business stuff.

They began by explaining to me who is really in charge and who is a trusted servant, who is a member of AA and who is a member of the meeting or group and who is not. They spoke about a group conscience and I figured that it was time for me to learn something new and this stuff sounded interesting.

They asked for volunteers to fill the groups service positions and seeing that nobody wanted to serve I raised my hand. However, they told me I was not even a good alcoholic; they hardly saw me at meetings anymore and they said they couldn't trust me. They thought I had a big ego.....and I was not there to call the shots. They asked if I knew my A, B, C's and I said yes.

They told me to start by cleaning ash trays, "brooming" the place and making coffee (AB&C) and if I did that then maybe they'd consider giving me a chance to take on a bigger commitment. In my culture, all these things are done by women so it was such a blow to my ego because I had never done those things at home 'I was too macho'. They told me I should arrive an hour early so that when the new comers came I could be ready for them. They wanted me to start giving back but again that was something totally foreign to me I had always been a taker.

In time, I got a hold of a Service Manual and it said the group conscience was going to guide me and from then on I began to listen. Today I am grateful to those old timers that showed me how to be of service at the group level, intergroup and General Service. It was through my willingness to be of service that I discovered the role of my home group in AA as a whole and how the GSR the link in the line of communication with other Groups and Districts and the General Service Office. I love the opportunity to serve and learn more new things about myself and about AA.

I now know about rotation and I find that concept fascinating because it forces me to get out of my comfort zone and do something different. I can honestly say that service work has kept me sober and I'm grateful to God for all the friends I've made along the way and all the things I've shared with them. I also find that the more I put in the more I get out, what a concept.

Having been a part of panel 62 and serving as Registrar of Area 09 has been a wonderful experience for me. There is some much more work to be done. There are so many meetings that need to be counted and they need our help. I am very grateful for the opportunity to serve God and you. God bless you all.

# GENERAL SERVICE REPRESENTATIVE

- Experience shows that the most effective G.S.R.s have been active in group, intergroup, or other service, where they have developed a desire to serve, and encountered situations in which the Twelve Traditions have been called upon to solve problems.
- Usually, prospective G.S.R.s have at least two years of continuous sobriety.
- They have time available for the district meetings, area assemblies and other service functions.
- They have the confidence of the group, and an ability to listen to all points of view.

G.S.R.s attend district and area meetings.

They serve as the mail contact with the General Service Office, and are listed in the AA directories as contacts for the groups. They receive the GSO bulletin *Box 4-5-9*, and keep their groups abreast of AA activities all over the world.

They supply their District Committee Member with up-to-date group information, which is relayed to GSO for inclusion in the directories and for GSO mailings.

They are knowledgeable about material available from GSO—new literature, guidelines, bulletins, videos, tapes, kits, etc.—and they are responsible for passing such information on to the groups.

They learn everything they can about the *Twelve Traditions and Twelve Concepts* and are familiar with the *A.A. Service Manual*, the books *Twelve Steps and Twelve Traditions* and *A.A. Comes*  of Age, Twelve Concepts for World Service, and the pamphlets "The A.A. Group," "A.A. Tradition—How it Developed," "The Twelve Traditions Illustrated," and "The Twelve Concepts Illustrated."


They are encouraged to serve on the group steering committee (or Group Conscience meeting).

They work with group treasurers to develop practical plans for group support of GSO, such as the Regular Contribution Plan and the Birthday Plan. They encourage the group to support the area and district committees and local central offices or intergroups, and they are familiar with the leaflet "Self-Support: Where Money and Spirituality Mix."

They participate in district and area service meetings, and often help with planning for area get-togethers and conventions. Following these events, they make reports to their groups for the benefit of those who could not attend.

The General Service Representative has the job of linking his or her group with A.A. as a whole. The GSR represents the voice of the group conscience, reporting the group's thoughts to the district committee member and to the delegate, who passes them on to the Conference. This communication is a two-way street, making the GSR responsible for bringing back to the group Conference Actions that affect A.A. unity, health, and growth. Only when a GSR keeps the group informed, and communicates the group conscience, can the Conference truly act for A.A. as a whole.

FINANCIAL SUPPORT: Current experience indicates that many groups provide financial support for their general service representative to attend service functions.

#### The Book


A.A. World Services, Inc. has announced the publication of the only authorized reproduction of the first edition of Alcoholics Anonymous. The book is priced at \$12.

The official publication date of the first printing of our Big Book, as noted by the United States Copyright Office, was April 10, 1939. There were 4,730 books printed, with red cloth binding, wide columns, thick paper (which was why it was called the Big Book in the first place), and a red, yellow, black and white dust jacket, which came to be known as the "circus cover."

# PANEL 64 AREA CHAIR: SHARES HER GRATITUDE IN SERVICE

It is Thanksgiving Eve and I can't sleep. The fact that what sounds like a little dog barking in the distance doesn't help either. My dogs are snoring so at least someone is able to get some rest. I haven't written too many articles for the newsletter but am compelled to write one tonight at 3:39am. I have a lot to be thankful for. My family, friends, health, God, and AA.

It wasn't until I moved to Corona that I got involved in General Service. H and I was my thing when I got sober in Long Beach and my sobriety family was very active in Harbor Area H and I. I had a Women's panel as well as the teenage girls ward at Norwalk Metro. Perhaps one of my most memorable panels was when a girl named Raven brought the Satanic Bible to our meeting. She didn't quote from it just felt compelled to bring it.

It wasn't until I got involved in Intergroup that I started learning how the traditions work through the groups. I was the Action and Responsibility chair for Harbor Area. One group needed to be addressed for mentioning the word "addict" in their group preamble. "Only addicts and alcoholics can share". The Chair and I addressed the secretary after the meeting and mentioned their group can do whatever they want but to stay in the AA directory you need to remove the word addict.

I'm glad we have these guidelines for Intergroup and as trusted servants in it's important to help educate about the traditions. Most AA's are only familiar with a handful.

As I reflect on Panel 62 and help transition Joe into Alternate Delegate, I couldn't be more proud of our Area and it's energy. We have a lot of passionate members and I hope the momentum continues.

What I've learned a lot about General Service is to trust the process. As my service sponsor says whenever I call to ask questions out of frustration or confusion "the body will take care of it". I've come to accept this and realize that she is right. I don't always agree with some of the proposals that are passed but have to accept that that is what the Area wanted.

One example of a proposal that passed this panel was to continue the Servathon on election years. It passed pretty overwhelmingly if I recall. Our Servathon in 2012, coming off the heels of this passing was extremely well attended with over 100 people. My question is, where was everyone that voted in favor of this at the 2013 Servathon? We had 40 to 45 people attend. The food kitty collection was \$59. One Roundtable had only the committee chair participating at his table. By the time the second Roundtable came up, committees started to combine. I sat at the Intergroup Roundtable and literature and really learned a lot. The Finance table not only talked about the budget but the economic feasibility of a Servathon on election years. I believe that for those that did show up we had a great time. The traditions play was so much fun and I thank all those who participated. Seeing Revo and Ramon in their acting debut was priceless.

As we go into Panel 64, it is my hope that the energy continues. I look forward to being your Chair.
