"You don't have to be afraid; A.A. is in good hands."

I began my general service in 1982 as a GSR from the *Living Sober* group in Corona del Mar. I was not a well-informed GSR as I didn't have any idea what General Service was about or what I was supposed to report on. I didn't know how to ask for a "group conscience" or "protect the Traditions". I listened to the Concepts, but couldn't make heads or tails of what they meant or how I might apply or understand them. At my first area meeting there was a disagreement between several members who were not happy with something in the Area Newsletter, which resulted in a physical skirmish...some pushing and shoving and perhaps a punch thrown or taken. I looked on, horrified, and wondered what I had gotten myself into. And even more astonishing, and perplexing at the time, all of those involved in the little "shoving match" went amicably out to coffee together after the meeting.

Later that month I heard a talk by our then current delegate, Dyanne G. She said, "You don't have to be afraid. A.A. is in good hands."

I had been developing a fear for A.A....I had been hearing a lot of anxiety from some members of our home group and others that the "druggies" were taking over and I wondered how I would stay sober if A.A. should somehow collapse or lose its focus or singleness of purpose. It wasn't only that Dyanne had made the statement that we needn't be afraid, it was how she said it: with conviction, a genuine humility, and a quiet passion. I heard what she said, but more importantly, I heard how she said it. I *believed* her. I had no doubt that she, and the others who reinforced her assertion in word and manner knew what they were talking about.

For over thirty years in General Service I have witnessed sacrifice, consideration, kindness, strength, awareness, wisdom, and love for A.A. and for its members. I have witnessed people finding ways to address disagreements in an agreeable and loving way. I have witnessed people who knew how to explain their positions and to cheerfully move forward when they didn't "get their way". I witnessed people who believed in the inherent wisdom of the process and didn't get angry, vindictive

or vengeful when things didn't turn out the way they thought was best.

Warranty Five of our Twelfth Concept states: "That no Conference action ever be personally punitive or an incitement to public controversy." Our Mid-Southern California Area 09 has always, in my experience and observation, tried to apply the principles described and discussed in Bill's essays on the Concepts, as well as the Traditions and Steps. In my opinion, the individual members of the Area Assembly, as well as the body itself, should also never take action that is personally punitive or an incitement to public controversy.

I have been overwhelmed with the amazing love and service I have observed from the vast majority of those with whom I have served. I have seen examples of self-sacrifice that, although not generally publicized and promoted, would inspire awe in anyone and certainly has in me. I have seen dignity in the face of humiliation, leadership in the face of personal attack. I have seen cherished plans and dreams discarded for those that turned out to be better, or at least more popular at the moment.

The most important thing I have learned so far (although I have *certainly* not mastered it myself) is that it is not *what* we think that matters; what matters is the manner in which we express it.

Can we be respectful? Kind? Courteous? Mindful of others' rights and feelings? Fully informed before we speak? Patient with those who have not yet learned how to be eloquent or respectful or kind?

Fear is toxic. "Sometimes we think that fear ought to be classed with stealing. It seems to cause more trouble."

I believe what Dyanne said and how she said it: "You don't need to be afraid. A.A. is in good hands." ... and those hands are yours and mine. Let us take each others' hands and work together ... unafraid ... with love and service, respectful and caring of one another ... even when we disagree ... or, perhaps, especially when we disagree.


We know many are excited about the International Convention and eager for detailed information. As the time gets closer, additional information about the Convention and Atlanta, our host city, will be provided.

Announcing the 75th Anniversary Edition of Alcoholics Anonymous

The Book

A.A. World Services, Inc. has announced the publication of the only authorized reproduction of the first edition of Alcoholics Anonymous. The book is priced at \$12.

The official publication date of the first printing of our Big Book, as noted by the United States Copyright Office, was April 10, 1939. There were 4,730 books printed, with red cloth binding, wide columns, thick paper (which was why it was called the Big Book in the first place), and a red, yellow, black and white dust jacket, which came to be known as the "circus cover."
