I say long awaited "service position" because I never imagined being here at this moment in time.

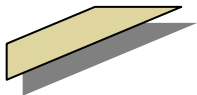

**January 1**

**1943** - Columbus Dispatch reports first Anniversary of Columbus, Ohio Central Group.

**January 2**

**1889** - Sister Ignatia is born in Ballyhane, Ireland.

**1939** - First sale of Works Publishing Co. stock is recorded.

**January 4**

**1940** - First AA group formed in Detroit, Michigan.

**2001** - Chuck C. from Houston died sober in Texas with 38 years.

**January 19**

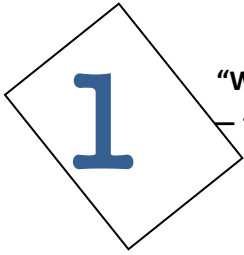
**1943** - First discussion for starting AA group in Toronto.

The Digital Archives page on aa.org has a new exhibit on Sam Shoemaker, one of the early nonalcoholic friends of A.A. Here’s an excerpt: “Dr. Shoemaker helped A.A. in fundamental ways. Physically, he provided refuge for alcoholics in New York through Calvary Church. Of greater importance was his spiritual aid, which directly influenced the Twelve Steps and the nature of A.A.’s program of recovery. 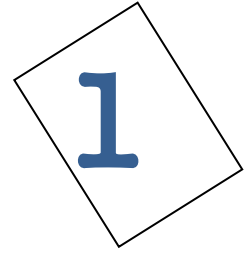

A questionnaire is being circulated for shared experience regarding the expressed need for a pamphlet for A.A. members who are Deaf. The questionnaire is available in print and as an in-house video version in ASL. The office is also receiving sharing from local committees and A.A. members working to carry the A.A. message to veterans and active duty members of the Armed Services. If you know anyone whose experience would be useful in either of these efforts to gather sharing from the Fellowship, please encourage them to participate. The newest AAGV publication, *Voices of Women in A.A.*, came out recently and has grossed \$34,800 – ten times what was budgeted. This is a clear indication that the message that this book carries is one that the Fellowship is hungry for! We spent some time reviewing and reaffirming General Service Board Strategic Plan goals and actions in support of those goals. There was a particular emphasis on the Third Tradition and its spirit of inclusion for all who suffer from alcoholism. In conjunction with this, we also discussed the importance of C.P.C. efforts to make sure that professionals who may be in a position to refer people to A.A. understand A.A. Increased understanding will make such professionals more likely to refer the suffering alcoholic to our doors. The communications audit that is part of the Strategic Plan has been started, and members of the firm we have enlisted to undertake the audit for us were with us over the weekend, engaging the Board in a dialogue about C.P.C. efforts on the Friday evening of the Board weekend and observing our committee meetings during the weekend.

During the Planning and Sharing Session we saw a presentation put together by G.S.O. financial analyst Michael M. He was able to really drill down into contributions to show us trends by area and region, as well as trends over time. I am hopeful that a version of this report will be available for me to show at PRAASA in March. Michael's ability to analyze the numbers and to create a valuable presentation was greatly enhanced by some recent training that the office supported. This training is part of a larger initiative that our General Manager has undertaken to support our staff in acquiring the most up-to-date skills that they need to do their jobs well – Greg's focus on Concept XI is greatly appreciated by the Board.

As part of his manager's report during the Planning and Sharing Session, Greg let us know that there was a recent problem with a long-time vendor who prints some of the versions of the Big Book for us. A significant number of soft-cover Big Books delivered to us had major imperfections in the cover. The customer service response from the vendor was described to us as being less than stellar. We have temporarily switched to another vendor until we can see whether the issue with the first vendor can be resolved. Once again, we are thankful to Greg for his attention to this problem and his forthrightness in keeping the Board informed.

We were briefed on legal matters during executive session. Work continues on the draft of a new book that collects Bill W.'s Conference talks. As you'll recall, the 67<sup>th</sup> Conference gave the green light to this project. The new working title is *Our Great Responsibility: Selections of Bill W.'s General Service Conference Talks, 1951-1970*. This proposed publication represents a significant trove of previously unpublished material from our co-founder, and I expect it will connect us with our history while giving us plenty to reflect on regarding our present and our future.

We heard a report from staff secretary Rick W. about the work being done to gear up for translating all Conference background material for the 68<sup>th</sup> Conference into French and Spanish. Professional translators will be used, and then some material will also be translated by volunteers so we can compare for quality and effectiveness. The anticipated cost is about \$100,000, which is less than previously-developed plans suggested. One reason for the reduced cost is the observation that about 40% of background material, on average, consists of already-translated material such as literature and service pieces.

A.A.W.S. requested time on the Conference week schedule to have a presentation and discussion regarding intellectual property and fiduciary responsibility, and the trustees' committee on the General Service Conference agreed with this request. Background is being developed that will go out with the rest of Conference background to facilitate a robust Fellowship-wide discussion of A.A. principles and history as they relate to the Board's responsibility to protect and be good stewards of A.A.'s intellectual property (such things as copyrights and registered marks – see pp. S77-S78 in the current Service Manual). I'm sure the session that will take place at the Conference, with delegates sharing about these issues, will be spirited and lively!

Under Treatment and Accessibilities, the committee continues exploring ways to better serve alcoholics who are members of the Armed Services. The committee is also in the early stages of discussing remote communities work.

The Corrections committee discussed a proposal for a new pamphlet for long-term incarcerated inmates and agreed to forward it to the 2018 Conference. The particular concern of the area that submitted the request is addressing the needs of long-term inmates who are about to be released.

We were given a breakdown of information on the \$7.27 on 7/27 initiative, which as you are aware is a grass-roots effort that started in the Pacific region and has spread throughout the service structure. It invites members and groups to make a contribution to G.S.O. on or about July 27<sup>th</sup> and to reflect when doing so on the amount that it costs per member per year to provide services at G.S.O. (\$7.27 in 2016, the latest year for which we have those figures). G.S.O. received 1,857 contributions in this effort, totaling \$76,829

These figures were part of the presentation by G.S.O. financial analyst Michael M. that I mentioned earlier in this report, and he was able to show us the contribution distribution using a sophisticated interactive map. When I asked how G.S.O. determined whether a particular contribution was part of the \$7.27 on 7/27 campaign, Michael answered that the department that processes contributions was on the alert for notes accompanying contributions that made reference to \$7.27 on 7/27. Thanks to our good workers at G.S.O. for tracking these contributions, and thanks above all to everyone who participated in expressing their gratitude through these contributions.

Mary C., staff secretary on this assignment, shared that the office heard from a member in Tashkent, Uzbekistan who has started an A.A. group. The member's name is Giulianna, and she was put in touch with G.S.O. through the Online Intergroup's Online Twelfth Step Committee. It's the first A.A. contact we have had from this country in three years, and the first news of a group being formed there. Giulianna shared that members are mostly people who have lost everything due to alcohol, and that many are struggling to stay sober. The group has received help and support from local churches, and they now want to get acquainted with the mosques. A package of literature has been sent from G.S.O. to assist the group in carrying the message. Work continues on the development for a plan for production of an anonymity-protected video of a virtual Regional Forum. The intention is to capture the essence of the information presented at Regional Forums to make it available for those who may never get to attend a Regional Forum. We received an invitation to participate in Al-Anon's 6<sup>th</sup> International Convention, which will be held in Baltimore, MD, July 5-7, 2018. The ICRF committee recommended accepting the invitation, and the General Service Board approved the recommendation. It's a great example of unity with our sister Fellowship.

The subcommittee on safety language in recovery literature presented its report of suggestions where language regarding safety might be added to existing literature, and that report is being forwarded to the Conference.

Work continues on the drafts of "A.A. for the LGBTQ Alcoholic," "A.A. for the Woman," and "A.A. for Alcoholics with Mental Health Issues." All three are nearing completion, and the committee had just one last suggestion for all three drafts – to add information regarding safety where appropriate.

Two related requests were discussed and forwarded to the Conference. One asked for a new pamphlet for atheists and agnostics in A.A. Similar requests have come in over the last few years from members who feel that "Many Paths to Spirituality" falls short of meeting this need, and the committee felt that the cumulative effective of these requests made it clear that it's time to send the suggestion along to the Conference. Another request asked that A.A. (U.S./Canada) publish "The God Word," a pamphlet currently published by the United Kingdom that addresses the needs of atheists and agnostics in A.A. This request came from within our structure, but we also learned during our discussion that A.A. in the U.K. has been in contact with us because they have received many orders from North American groups and members for this pamphlet, and they are no longer able to meet the need because of costs.

Another literature request being forwarded to the Conference is a request for a pamphlet on A.A.'s Three Legacies to include member sharing about Recovery, Unity, and Service.

The committee forwarded to the Conference a motion from an area regarding a reorganization of the A.A.W.S.

Board and the General Service Board, as well as another motion from an area to censure the General Service Board. Both of these motions are in response to the G.S.B.'s recent decision to authorize the A.A.W.S. Board to take legal action regarding the printer's manuscript of the Big Book.

We received an update on the creation of a Google for Nonprofit YouTube account, which was authorized by the 67<sup>th</sup> General Service Conference. It is expected to be launched by January 2018. I'm looking forward to seeing how it operates as a vehicle for carrying the message.

We reviewed an excellent presentation on Google AdWords and Google Grants. This presentation was put together by our two appointed committee members currently serving on the committee, Allison C. and Shari M., both of whom have strong professional credentials related to the use of current media. Their presentation helped us see how effective Google AdWords could be at improving A.A.'s placement on search results related to alcoholism, alcohol treatment, and finding help for a drinking problem. In short, a Google AdWords account can make it more likely that a suffering alcoholic searching online for help would see our website in their search results. The portion of the presentation about Google Grants, which is Google's way of making Google AdWords available to nonprofits like ours, also raised interesting questions about Traditions, specifically Tradition Seven and whether using Google Grants constitutes accepting a contribution from an outside entity. We'll be continuing our discussion so that we can give a full report to next year's Conference, since the exploration of this topic is in response to an additional

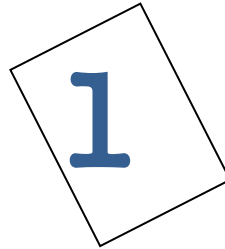
committee consideration from the Conference P.I. committee.
