In FNV all GSR, DCM, DCMC and New Group kits requests were generated when one of these positions was updated with a new person. That process has changed at GSO and at their3 warehouses, so please prepare new position holders for this change. What does it mean? Kit delivery will take a bit longer than previous. The 7-10 business delivery time may move more to a 10-14 business delivery period. I do want to add that only GSRs receive the new kits. Not alternate GSRs.

So continuing to work with the Finance Committee to prepare the 2020 Budget. We have distributed budget request forms; hopefully, we will receive all the requests back today or sometime soon. For all committees, I do want to remind you that our groups and membership in our Area are very generous and we have funds available. For the Panel next year you want to be sure, even if you are rotating out, to make sure your committee has funds available to provide these essential services we need. I prepared a budget report with expense up to September 6. I want to thank Mitchell for getting paper copies available today. Currently, our contributions are \$62,419.52 and our budget projection \$58,849.71, so you can see we are \$3,569.81 ahead of projections. We started out a little better than we projected. So we are in good shape and that is a good thing. I did provide information to the Audit Committee as requested and hopefully it checks out. Since our last meeting I attended the Board Meeting, I attended the *Technology in AA* workshop hosted by District 4 on August 24. I want to thank District 4 for hosting the event and some of the event planners are hear today – Maryka was helping and others here today. Delicious pie and great workshop topics, great apps available, some concerns people have about anonymity, and safety issues related to online. I attended the 16th Annual A.A. Mountain Conference in Big Bear. It is almost like a retreat, very spiritual, speakers were great, Big Book workshop, fellowship and a really delightful setting. That was a great place to go. In the future I am committed to assist at the Area 08 elections and District 04 elections. There will be more work with other district elections we will be going to as well. As of this morning, our checking account is \$35,295.16. The Prudent Reserve balance in our savings account is \$7,500.15. Thank you so much for letting me be of service.

Alcohol gave him a personality change. But, when he got to place where he needed to stop, he was able to stop and stay stopped. He got lymphoma, he got cancer three and beat it three times. Each time he got a cancer diagnosis he said, "Oh, cancer. Cancer loves sugar. Alcohol turns into sugar. I 'm not drinking alcohol anymore." He stops and he stayed stopped and he stays happy. All I know is that my father is deeply, deeply grateful to Alcoholics Anonymous. You made me into the kind of son he was trying to create. I am really grateful for that. At the Elections coming up next month, please note my amazement and joy that about serving as Chair. For about nine hours a month I get to have absolutely no opinion, whatsoever, which I did not know was desirable or even possible. It has been amazing. My job is primarily to draft the agendas for the Area and Board meetings, to incorporate feedback about the topics into the agendas, and to chair the meetings so they run smoothly. Meeting with Districts to insure their health. So if you are enthusiastic about and eligible and thinking about standing for Area Chair please do. The geography of Japan is about three-quarters the size of California and it has little less than half the population of the U.S. When A.A. was 40 years old in the U.S. we already had a million members. It is 45 years in Japan they only have 5,700 members. That is because the culture and the role of shame. As a Japanese-American translator I was made in Japan. I was still really benefited from the culturally beneficial effects of shame. In Tokyo there are no trashcans and no little. Everyone hikes out all their trash; they don't want to be burden on anyone else. In Japan, I'm finally in Japan sober and I don't see anyone on their cellphone or speaking on their cellphone or headsets playing music from phones or devices in public. That is because no one wants to be a burden on anyone else. I don't have that problem. But I do have the shame. Shame is what prevents so many Japanese alcoholics from getting sober in Alcoholics Anonymous. This past PRAASA, getting a chance to host the visiting Japanese Delegates and Trustees and interpreting for them was amazing. Getting to go back on interpret again will be amazing. If it is too soon for you and you d not have money and a passport by March 2020 please remember in March 2025 it will be in Tokyo, instead of Osaka, and will be the 50th Anniversary. That year the International will be in Vancouver BC, which is just a road trip from the coast, so it will be a lot less expensive. Save up for 2025. What is really cool is that our Area interpreter Maria de la E., who is hear this morning, will be traveling with me. Any Spanish speaking A.A.s who want to come along will have an interpreter who is coming along, which is just amazing. Sharon K. is coming with a friend of hers, a member of the Japanese speaking group in Gardenia, I have a sobriety brother in Las Vegas is coming. Paul came up to talk with me, saying that he wants to come as well. Please do come. I'm all paid up to go with the Pacific Group to attending 2020 International in Detroit. Once again, Motown Museum only allows access to the giftshop or tour by appointment. Make your appointment today. Next year's A.A. travel calendar consists of March PRAAASA in Tucson AZ, Japan the last two weeks of March, International Convention in Detroit in July, the Pacific Regional Forum in Las Vegas in September, and also in Las Vegas the Statewide Retreat in December.
