BOB'S NIGHTMARE, AA NUMBER 3 AND THE APPENDIXES ALL REMAIN AS THEY APPEAR IN SEPTEMBER 2022 AND WILL NOT CHANGE EVEN WITH THE WRITTEN CONSENT OF ANY PERCENTAGE OF THE AA GROUPS, THE GENERAL SERVICE CONFERNCE, A PUBLISHING COMPANY OR ANYOTHER PERSON OR ENTITY. ADDITIONALLY, no change in Article 12 of the Charter or in A.A. Tradition or in the Twelve Steps of A.A. may be made with less than a written consent of three-quarters of the A.A. groups, as described in the resolution adopted by the 1955 Conference and Convention." This motion would rescind the Advisory Action from the 71st GSC which changed the A.A. Preamble language from "men and women" to "people" at a time when gender neutrality became a popular topic in politics in the year 2021, which is when our A.A. Preamble was changed. Our A.A. Preamble has existed since 1947. If "Men and Women" was not inclusive, the A.A. Preamble would have been changed to "People" in the 74 years prior to 2021. Gender neutrality is one of the most political and controversial topics of our day and age today. The A.A. Preamble says that "A.A. is not allied with any sect, denomination, politics, organization, or institution, does not wish to engage in any controversy, neither endorses nor opposes any causes." Tradition 10 says that "Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy." Our book, Twelve Steps and Twelve Traditions, states in Tradition 10, what happened to the Washingtonians when they formed opinions on outside political controversial issues (the abolition of slavery and the temperance movement). This is what destroyed the Washingtonians, and how A.A. got our 10th Tradition. We trust our servants to act in the best interest of A.A. as a whole and not cave to political and social agenda pressures of the society at large as did the Washingtonians. The Fellowship of A.A. holds our 21 trustees, area delegates, general service office, and A.A. corporations accountable to not endorsing or expressing opinions on outside political controversial issues through our A.A. literature.</p>	AA Grapevine Board	<p>The 73rd General Service Conference Committee on Grapevine and La Viña reviewed and discussed this issue thoroughly in April 2023 and took no action. The Grapevine Chair and the 73rd Conference Committee on Grapevine and La Viña met in October 2023 and reviewed these proposed agenda items.
